Vestry maintains the possibility that the property may need to be sold at some point in the future if substantial finance is required, however at this point Hilton Place has been rented and is providing a good return in a market that has proven favourable to property and rental investment.

Over the last few months vestry has been intentional in working to develop a plan ensuring all investment properties together with the vicarages are managed and maintained for optimum return on investment into the future. Income from these investments have long supported parish mission and ministry and this remains a vital financial revenue stream. Alongside this we are seeking to utilise this investment income to build up reserves to potentially help fund some significant future expenses including the earthquake strengthening and renovations of the church. While Nativity has substantial financial expenditure over the coming decade we trust and believe that God who is able to do immeasurably more than we ask or imagine is very aware of our needs.
